2. **Dr. Ir. Munzir Busniah, MSI**  
Dekan Fakultas Pertanian Universitas Andalas berkedudukan di Kampus Unand Limau Manis - Padang 25163, selanjutnya disebut **PIHAK KEDUA**, selanjutnya disebut **PIHAK KEDUA**.

Kedua belah pihak secara bersama-sama menyatakan telah sepakat dan mengikat diri, mengadakan kerja sama dalam pelaksanaan kegiatan pengujian efikasi registrasi pestisida dengan ketentuan sebagaimana tertuang dalam pasal-pasal berikut ini:

**Pasal 1**  
**RUANG LINGKUP PEKERJAAN**

1. **PIHAK PERTAMA** dalam kedudukannya seperti dimaksud di atas, memberi tugas kepada **PIHAK KEDUA** dan **PIHAK KEDUA** menerima tugas tersebut untuk melaksanakan pengujian efikasi registrasi pestisida.
2. Ruang Lingkup Pekerjaan dan tugas yang diterima **PIHAK KEDUA** seperti yang dimaksud dalam Pasal 1 ayat 1 adalah membantu pihak PT. DuPont Agricultural Products Indonesia melaksanakan pengujian efikasi registrasi pestisida.
3. Dalam melaksanakan: pengujian efikasi registrasi pestisida, **PIHAK KEDUA** berpedoman kepada Protokol yang telah disetujui oleh **PIHAK PERTAMA** dan Komisi Pestisida-Kementerian Pertanian RI sebagai acuan.

Today, dated the fourth day of December year two thousand and seventeen year two thousand and seventeen, we the undersigned:

1. **Eggy Nilamsari**  
Director of PT. DuPont Indonesia, domiciled in Beltway Office Park Building A, 5th floor, Ampera Raya Street Number 9-10, Jakarta 12550, is hereinafter referred to as **FIRST PARTY**.

2. **Dr. Ir. Munzir Busniah, MSI**  
Dean of Faculty of Agriculture, Andalas University domiciled in Campus Unand Limau Manis - Padang 25163, is hereinafter referred to as **SECOND PARTY**.

Both parties have agreed upon and are bound to enter a collaboration with each other to implement the efficacy test for pesticides registration as stated in the following provisions:

**Article 1**  
**SCOPES OF ACTIVITIES**

1. **FIRST PARTY**, on the position as referred to, shall assign **SECOND PARTY** and **SECOND PARTY** accepts the duty to conduct the laboratory test and/or efficacy trial and for pesticides registration.
2. Scope of the Activity and the duty accepted by **SECOND PARTY** as referred to in Article 1 paragraph 1 is to help PT. DuPont Agricultural Products Indonesia to implement the laboratory test and/or efficacy trial for pesticides registration.
3. Upon implementing the laboratory test and/or efficacy trial for pesticides registration, **SECOND PARTY** shall refer to the Protocol that has been approved by **FIRST PARTY** and the Pesticides Committee of the Ministry of Agriculture of the Republic of Indonesia.
