Maybe, the addition of a fabrication schematic is a good idea. - The results seems to be insufficient to support the claimed statement by the authors "when applied to water polluting bacteria E.Coli, the all prepared NCBs were able to reduce it by more than 90%. The effectiveness of NCB to remove microbial contamination, especially bacteria, looks very promising with or without TiO2 and graphene reinforcement treatment."
